Please read all statements below. Your signature on the Membership Form will demonstrate you have read, understood and agree to these terms and conditions.

1. I understand that I must **abide by the Rules and By-laws** of the club and I must obey the lawful and reasonable directions of the Captain and Committee members, as provided by the Rules.
2. To the best of my knowledge, I am **not suffering from any condition** that would prevent and/or render me unfit to participate in rowing activities. I confirm that I will advise a member of the Shoalhaven Rowing Club Committee immediately in writing if I suspect that these circumstances have changed.
3. I confirm I can **swim 100 metres** in rowing clothes.
4. I agree to **pay subscriptions and any debts** I may incur to the Club's Treasurer in a timely way.
5. I understand that, if I **choose to compete**, I must be a registered financial member of Rowing NSW.
6. I understand that Shoalhaven Rowing Club **does not provide personal accident insurance cover** for me while I participate in the activity of rowing. This insurance cover is provided by Rowing NSW for its members, as detailed on their website.
7. I understand that Shoalhaven Rowing Club shall retain and use **personal information about me** in accordance with the Club's privacy policy**, available on the Club's website, and which I have read and understood.
8. I agree that **photos** which may include images of me may be used by Shoalhaven Rowing Club in **promotions**, including in newspapers and on social media.
